The Board of County Commissioners of Butler County, Ohio met in Regular Meeting on the 4th day of October, 2021 in the Commission Chambers of the Butler County Government Services Center, 315 High Street, 2nd Floor, Hamilton, Ohio 45011.

**Whereas** the Board of County Commissioners, pursuant to ORC 325.19(D)(1), is required to provide holiday pay to full time county employees;

**Whereas** the 134<sup>th</sup> General Assembly enacted Amended House Bill 110, effective September 30, 2021 determining the legal holidays for employees;

**Whereas** by authority of ORC 325.19(F), the Board does hereby adopt the following alternative schedule of legal holidays for Butler County during the year 2022, which the schedule is not inconsistent with the provisions of collective bargaining agreements governing bargaining-unit employees of Butler County:
